The engagement will be offered purely on Contract basis for the period of one year which can be renewed as a fresh contract on year to year basis or till the scheme is available whichever is earlier.

Terms & conditions: -

- 1) Appointment will be purely on contract basis & on fixed remuneration.
- 2) The engagement will be for one year from the date of engagement and will be renewed thereafter.
- 3) Selected HVS will be engaged at Divisional Railway Hospital, East Coast Railway, Khurda Road.
- 4) Complete Terms & conditions can also be obtained from the office of CMS, E. Co. Railway, Khurda Road or from www.eastcoastrail.indianrailways.gov.in.
- 6) Short listed Doctors shall be intimated within one month of receipt of applications.
- 7) One set of complementary Railway Pass valid all over Indian Railway & Konkan Railway in AC two tier including Rajdhani Express and in AC Chair Car of Shatabdi Express for self + spouse and dependent Children (as per rules applicable for Railway employees) will be made available as per the entitlement of Selection Grade Officers in each calendar year.
- 8) The Complementary Pass can be availed after 03 months of engagement of calendar year.
- 9) HVS will have no right of posting against regular or transfer on request.
- 10) The Candidates working in any Medical Organization/State Govt. Should submit their application through proper channel with "No Objection Certificate".
- 11) HVS engaged on contract basis in the Railway will not to have any claim or right for his/her continuity in service or automatic extension to the term of contract service. The service rendered as a HVS will not confer the right to take weightage for regular selection through UPSC and also will not confer any right for regularization or absorption.
- 12) Offer of engagement will be issued in favour of selected candidates, the candidates should report within 15 days from the receipt of offer letter.

Selection will be made on the basis of screening of papers (related certificates). The Honorary visiting Specialists will not be

called physically at the time of selection. The applicant should furnish the following certificates along with prescribed format at the time of application.

- (b) Proof of passing Post Doctoral (DM/MCh/or equivalent); Post Graduate Degree/Diploma & other educational certificate issued from a recognized Institution/University.
- (c) Proof of registration in Indian Medical Council/Medical Council of State.
- (d) Mark Sheet(s) of relevant qualification.
