**"WALK-IN-INTERVIEW" NOTICE:**

A walk-in-interview will be conducted for engagement of one Contract Medical Practitioners (Specialist in Pathology) (CMP) on full time contract basis in East Coast Railway from open market, retired Railway Doctors and retired Government Medical Doctors of State Government and Central Government for a period of one year which can be renewed as a fresh contract on year to year basis on willingness of concerned CMP, not extendable beyond 12 years or till the scheme is available whichever is earlier. The details are given below:-

**NO OF VACANCY.-** 01 at Central Hospital, Mancheswar, Bhubaneswar

**EDUCATIONAL QUALIFICATION/ELIGIBILITY :**

Post-Graduation degree from a recognized University. Minimum 03 years experience in the professional works related to concerned Speciality after obtaining PG degree.

**AGE :**

- Not exceeding 53years of age as on 23.01.2019. However, age relaxation is admissible for SC/ST/OBC category candidates as per rules.
- For retired Railway Doctor, retired Government Medical Doctors of State Government and Central Government: Age up to 64 years as on 23.01.2019.

**REMUNERATION :**

- Monthly remuneration is ₹ 95,000/-(including HRA & Transport Allowance) for 1<sup>st</sup> year and Rs. 1,05,000/- for 2<sup>nd</sup> year onwards.
- For retired Railway Doctors, retired Government Medical Doctors of State Government and Central Government, the monthly remuneration is ₹ 46,000/-. Subject to the condition that the pension plus contractual remuneration of the Retired Doctors should not exceed than the last pay drawn at the time of retirement. No Dearness and any other allowances which are admissible to regular Railway Servants shall be admissible.
- Normally Sundays and National Holidays will be off and in addition, authorized absence without detriment to the terms shall be allowed at the rate of two days per month to be availed any time during the contract to the extent earned by the CMP (Specialist) till such time subject to fulfillment of conditions. Daily rate of proportionate reduction from the remuneration in the event of excess absence will be applicable.
- In case Railway accommodation is provided to the CMP(Specialist), an amount equivalent to HRA and license fees of the accommodation so provided shall be deducted from the monthly fees admissible

**VENUE, DATE AND TIME OF "WALK-IN INTERVIEW":**

Eligible and willing candidates should report at the venue given below along with the original certificates and self attested photocopies of certificates showing date of birth, educational qualification, community and two passport size photographs. Besides these, retired doctors should bring original P.P.O.(pension payment authority), service certificate & LPC along with attested photo copies of all.



**OTHER TERMS AND CONDITIONS :**

- No TA/DA/Accommodation will be provided to the candidates attending the interview.
- Selected candidates will be subjected to medical examination. At the time of entering in to contract, the CMP( Specialist) shall produce certificate of his/her character and antecedents from two gazetted officers of the Central/State Govt.

3. The full time Contract Medical Practitioner who enters contract with Railways will not have any claim or right for his/her continuity or automatic extension of the term of contract.
4. During the validity of the contract, the CMP will be at liberty to terminate the contract for betterment of his/her career or any other ground by giving 15 days prior notice to the Railways. The contract can also be terminated by the Railways at any time during the contract by giving 15 days notice without assigning any reasons whatsoever. The contract shall also be terminated by the Railways administration if the CMP is found to be mentally or physically incapacitated.
5. It will not confer any right for automatic regularization or absorption in railways.
6. The CMP may avail of free medical treatment for self only except operations categorized as 'special' in para 622(8) of IRMM 2000 and treatment normally available at super speciality centre from his/her respective zonal railway hospitals during the currency of contract.
7. The detailed instructions with regard to the duties while in contract in Railways shall be given to CMP concerned in the event of selection along with the offer of engagement.
8. Appearance in the interview will not vest any right upon the candidate to be engaged as CMP & no reasons will be cited or communication shall be made with the candidate in the event of candidate not getting selected.
9. The administration of the ECoR reserves absolute rights to cancel this notification without assigning any reason(s).
10. One set 1<sup>st</sup> class complimentary Railway pass for self and family during each contractual year shall be issued after 03 months continuous engagement.
11. No Railway privilege passes/PTOs shall be admissible to Retired Railway Doctors engaged as CMP in his/her capacity of CMP.


