

Subject: Implementation of Government's decision on the recommendation of the VIIIth Pay Commission on CCS (Extraordinary Pension) Rules, 1939 -- Constant Attendant Allowance -- regarding.


In continuation of this Department's OM No.1/4/2017-P&PW(F) dated 2<sup>nd</sup> August 2017, revising the Constant Attendant Allowance from the existing Rs.4500/- p.m. to Rs.6750/- p.m. it has also been decided that the rate of Constant Attendant Allowance payable to the Civilian pensioners shall be increased by 25% every time the dearness allowance on the revised Pay in the Pay Matrix increases by 50%.

2. All other terms and conditions of this Department's OM NO. 1/4/2017-P&PW(F) dated 2<sup>nd</sup> August 2017 will remain the same.

3. In so far as persons belonging to Indian Audit and Accounts Department, these orders issue after consultation with the Comptroller & Auditor General of India.

4. These orders are issued with the concurrence of the Ministry of Finance (Department of Expenditure) vide their OM No.11-1/2016-IC dated 11.07.2017 and ID No.11-1/2016-IC/Pt dated 25.07.2017.
