
Sub: Allotment of marks in selection under the head Seniority.

Prior to issue of guidelines by Railway Board for elimination of viva voce in selections, 15 marks was allotted under the head seniority following the guidelines of SER's Estt. Srl. No.63/85. Senior most candidate called for selection was awarded 15 marks for seniority and the junior most was being awarded 5 marks where there were 10 candidates or less called for the selection. Similarly where there are more than 10 candidates, 15 marks was awarded for senior most candidate and 2.5 marks for junior most.

The Viva-Voce has since been eliminated from the recruitment process in most of the selections and 20 marks out of 100 are being allotted under the head seniority in terms of Para219(g)/IREM-I.

It has now been decided that irrespective of the number of candidates called for selections the senior most candidate shall be awarded 20 marks for seniority and the junior most candidate shall be awarded 12 marks.

This should be followed uniformly without any deviation. All other rules in vogue governing the selection procedure will remain unchanged.
