Sub: Implementation of recommendations of Seventh Central Pay Commission accepted by the Government – Qualification Pay renamed as Railway Accounts Examination Allowance.

Consequent upon the decisions taken by the government on the recommendations of the Seventh Central Pay Commission relating to revision of allowances, it has been decided to change the nomenclature of Qualification Pay to Railway Accounts Examination Allowance. The rates of Railway Accounts Examination Allowance (erstwhile Qualification Pay) are revised as under:

Category	Existing Rates	Revised Rates
Clerks Gr.II (Accounts Clerks)/Typists on passing App-II Examination	₹ 180 pm	₹ 405 pm
Sr. Accounts Assistant/Accounts Assistant/Stock Verifier/Typist/Stenographer on passing App-III Examination	First Year	₹ 240 pm

- The amount of Railway Accounts Examination Allowance will further rise by 25 percent each time DA rises by 50 percent.
- This allowance will not be treated as a part of pay for the purpose of fixation of pay in promotion to next higher post.
- The revised rates of this allowance shall be admissible with effect from the 1st July, 2017.
- This issues with the concurrence of the Finance Directorate of the Ministry of Railways.


