- NB: (i) In terms of Railway Board's letter No.2018/E(GR)/9/2 dated 09.07.2018, Shri Saurav Saini, IRSSE Probationer of 2016 Exam batch has been allotted to E.Co.Railway and has completed centralized training at IRISSET/Secunderabad as per Director/IRISSET's Gazetted Office Order No.02(TRG) of 2019 dated 25.01.2019. He has reported to ECoR on 28.01.2019(FN) and proceeded on sanctioned leave w.e.f. 29.01.2019.
- (ii) The Sr.Scale(ad-hoc) panel/Select list of S&T officers at S.No.(3 & (13) has been approved by the General Manager/E.Co.Railway on 07.02.2019 for their officiating promotion to Sr.Scale on ad-hoc basis for a period not exceeding one year without specific approval of the Railway Board. Their fixation of pay in Sr.Scale (ad-hoc) will be made under normal operation of rules.
- (iii) In terms of Railway Board's letter No.E(Trg)2007(22)/4 dated 11.10.2007, Group 'B' officers are required to undergo BFP & BIP training courses within one year of promotion to Gr.B service. Otherwise, they would not be considered for adhoc promotion to Sr.Scale as well as empanelled to Gr.A services. Hence, Shri R.K. Jha (DOP to Gr.B/S&T: 26.10.07) who has not yet undergone these courses, may be booked for the same at the first opportunity when the courses start next.
- (iv) The provisional panel of Group-C/S&T staff at S.No.(6), (7) and (9) for their appointment/promotion to Group-'B' service as ASTE in S&T Department of E.Co.Railway has been approved by the General Manager/E.Co. Railway on 31.01.2019 and is in terms of PCPO/ECoR's Memorandum No.ECoR/Pers/Gaz/S&T/ASTE-70%/Select Panel/2017-19 dated 07.02.2019. Their promotion is subject to their not undergoing any punishment under the RS D&A Rules, 1968. They may exercise option for fixation of pay in Group'B'/S&T service as ASTE within one month from the date of their promotion in terms of CPO's Estt.Serial No.231/81 and as per extent rules.
