Sub: AVC for promotion to the post of Commercial Inspector (PB-2, GP Rs.4200/-) against 75% Departmental Quota in Commercial Department.

After consultation with both the recognized labour unions, approval of General Manager is hereby communicated for revision of AVC for promotion to the post of Commercial Inspector (PB-2, GP Rs.4200/-) against 75% Departmental Quota in Commercial Department.

Accordingly, henceforth, the staff belonging to following categories of Commercial Department will be eligible for promotion to the post of Commercial Inspector (PB-2, GP Rs.4200/-) against 75% Departmental Quota.

- (1) Sr. Commercial Clerk (PB-1, GP Rs.2800) & Tracers (PB-1, GP Rs.2400)
- (2) Sr. Ticket Collector/TTE (PB-1, GP Rs.2400)
- (3) ECRC (PB-1, GP Rs.2800)

The following guidelines are issued for the selection for promotion to the post of Commercial Inspector (PB-2, GP Rs.4200/-) against 75% Departmental Quota.

- (1) This will be a general selection by calling volunteers from the above feeder categories (RBE No. 161/2009).
- (2) Sr. Commercial Clerk (PB-1, GP Rs.2800) & Tracers (PB-1, GP Rs.2400), Sr. Ticket Collector/TTE (PB-1, GP Rs.2400) & ECRC (PB-1, GP Rs.2800) of the respective divisions will be entitled for seeking avenue against the posts notified by that particular division.


However, eligible employees in the aforesaid grades and categories of all three divisions are entitled to appear in the selection, notified by the HQrs for the vacancies existing in the HQrs.

- (3) While notifying to fill up vacant Commercial Inspector (PB-2, GP Rs.4200/-) posts (against 75% Departmental Quota), 33.33% of total vacancies will be kept aside for Sr. CC & Tracers. Balance 66.67% of total notified vacancies of Commercial Inspector will be kept aside for ECRC & Sr. TC/TTE.
- (4) After taking qualifying (written) examination, if Administration does not find

qualified candidates (in terms of merit) from remaining (integrated) qualified candidates will be considered irrespective of categories.

- (5) The existing instructions with regard to reservation of SC/ST wherever applicable will apply.
- (6) After empanelment, candidates have to attend promotional course training as prescribed.

These instructions will take effect from the date of issue of this letter. However, any selections/panels initiated but not finalized till date, shall cease to exist.
