Sub: Running of freight trains on CC+8 routes.

Ref: (i) Board's letter No.2018/E&R/1(8)/4 dated 24.04.2018, circulated to Divisions vide this office letter No.CCM/356/Policy/PCC/Pt.VII/628 dt.24.05.2018.

(ii) Rates Master Circular/PCC/2015/0 dated 19.10.2015 and Corrigenda thereto circulated vide CCM/ECOR's Commercial Circular No.136(G)/2015 dated 20.10.2015 and Corrigenda thereto.

- 1.0 In terms of Board's letter referred at (i) above, Eastern Railway have forwarded proposal with due approval of the General Manager to include the section Gosaingram - Nalhati Jn (GSGB)-(NHT) (Up & Dn line) including Gsaingram – Poradanga (Y- connection) in the CC+8 route.
- 2.0 Please refer to Annexure III to Rates Master Circular referred at (ii) above wherein list of CC+8 routes is prescribed. Now, sanction of the Competent Authority is hereby accorded to include following route in the list of already identified CC+8 routes.


