Sub: Filling up of vacancies in the category of Hospital Attendant/Ayah in Level-1, on the basis of seniority & suitability in Central Hospital/BBS.

The following vacancies in the category of Hospital Attendant/Ayah in Level-1 in CH/BBS is proposed to be filled up by inviting applications from amongst the serving Safaiwala (House Keeping Assistant-Medical) category of Railway Hospitals working in CH/BBS & HU/Rail Vihar, irrespective of length of service.

- The vacancies shall be filled by a process of screening on the basis of seniority & suitability.
 - The suitability shall be assessed by a duly constituted Screening Committee through screening of Service Record and last three years Performance Reports. The employees should be free from SPE/Vigl/DAR cases.
 - The movement from Safaiwala (House Keeping Assistant-Medical) in Level-1 to Hospital Attendant/Ayah in Level-1 does not amount to any promotion but change of category only. Hence no pay fixation will be allowed.
 - The employee so selected shall be assigned bottom seniority in the category of Hospital Attendant/Ayah.
 - The staff applying in response to the notification will not be allowed to withdraw the option in the event of his/her selection.
 - Applications should be submitted in Annexure 'A' format only (attached). The application would be submitted to the controlling officer, who in turn will forward the same to PCPO's office HQ.
 - Last date for submission of application by the employees to their Controlling Officer is 23.03.2019 which should reach at PCPO's Office by 01.04.2019 positively.
 - This should be given wide publicity amongst the staff and copy of the notification may be placed on the office Notice Boards also.
