### MEMORANDUM

Approval of General Manager, East Coast Railway is hereby communicated for revision of Diet Charges. The Diet charges to be recovered from serving and retired railway employees and their dependents while undergoing treatment as indoor patients in the Railway Hospitals of East Coast Railway on **No Loss No Profit Basis**. The details are as under:

Sl.No.	Description of diet	Present Rate(in Rs)	Revised Rate (in Rs)
1	Milk & bread	73	102
2	Light diet	86	126
3	Full diet (veg)	119	152
4	Full diet (non-veg)	126	162
5	Half diet (veg)	97	131
6	Half diet (non-veg)	115	137
7	Diabetic diet (veg)	113	149
8	Diabetic diet (non-veg)	136	150

This is subject to the following terms and conditions:-

- 1) The guidelines issued, vide Railway Board's letter No. 2005/H/23/6 dated 29.01.2010 is to be adhered to.
- 2) The revised rates will be the basis for estimation and tendering and the rate at which the tender is finalised/work is out sourced for a particular hospital will be the rate of recovery for that hospital.
- 3) Any patient from whom diet charges are to be levied for diet and who takes diet from the hospitals may be charged for the full day, if the patient has been admitted before 12:00 hours in any particular day and only half diet charges if the Patient admitted after 12:00 hours.
- 4) The revised rate of diet charges is effective retrospectively from 11.07.2016 i.e. the date of approval of the competent authority (GM/BBS) till further revision.

This is issued on the recommendations of 3<sup>rd</sup> Diet Review committee of ECoRly which has been concurred by FA&CAO/BBS, and approved by GM/BBS.
