

In continuation to Board's letters referred to above it is further clarified that in the event of Cashiers & Shroffs of Cash & Pay department **having being declared surplus**, Board's instructions issued vide letter no. E(NG)II-84/RE-1/10 dated 21/04/1989 and E(MPP)/99/1/75 dated 28/11/2000 are equally applicable to them.

Incidentally, for redeployment of staff who have been declared surplus, Board's instructions issued under letter no. E(NG)II-84/RE-1/10 dated 21/04/1989 apart from others envisages that where the posts are not vacant and staff are working against them, 'Special Supernumerary' posts in the same grade are to be created and credited as Special Supernumerary posts to the 'bank of surplus posts' and maintained in the respective billing units. Further the Special Supernumerary' posts are personal to each incumbent and are to be surrendered as soon as the incumbent is absorbed in some other duly sanctioned posts or retires or vacates it for any other reason.
