The Central Vigilance Commission have taken cognizance to overstaying of officials beyond their tenure in the vigilance department in one of the zonal railways, and have advised as under -


- i) To ensure that instructions/circulars of the Commission/Railway Board regarding rotational transfer of official working in the sensitive posts are followed scrupulously in all units of Railways.
- ii) To put a system in place for automatic reversion of the officials back to their parent unit after expiry of the deputation period.

Zonal Railways are requested to strictly follow the rotational policy laid down in respect of sensitive posts and also take necessary steps to revert officials back to their parent units after expiry of their deputation period without any let up. This may kindly be ensured.
