
Sub:- Tenure of deputation of IR officers with Railway PSUs/Organisations – non grant of NOC regarding.

In terms of extant policy, the deputation tenure of officers/staff in PSUs/Autonomous bodies under the administrative control of this Ministry is restricted to 5 years (with due approval for 4th & 5th years tenure, wherever initial deputation was for 3 years). Accordingly, extension of deputation tenure of Railway servants beyond a period of 5 years at a stretch is not being processed. Borrowing organizations have been requested to process repatriation of those staff who have already completed the sanctioned tenure and where no further extension has been approved by the Ministry.

However, borrowing organizations are still referring cases to Board for extension of deputation tenure beyond 5 years after obtaining the parent Railway's NOC. By the time the proposal comes to Board's office, overstay beyond the prescribed tenure has often occurred.

In order to address this problem, Railways are clearly advised not to grant NOC beyond 5 years deputation tenure and make this clear sufficiently in time to the borrowing organization so that overstay is avoided.
