



Vide Board's letter referred to above, it was suggested to all Railway/PUs that they could consider holding Suitability test/examination for Compassionate Ground Appointment (CGA) candidates on a fixed date every month- say, the 10<sup>th</sup> of the month.

2. In order to ensure uniformity on this aspect and for the benefit of all CGA candidates, it is now reiterated that the suitability test/examination(s) for CGA candidates be conducted on the 10<sup>th</sup> of every month as a standing practice. This may be given due notice/circulation for the benefit of eligible candidates.

3. Where the 10<sup>th</sup> of the month is a holiday, the screening/examination shall be conducted on the next working day. The above may be implemented, where not already done, from the month of April 2019.



**Sub:** Timely disposal of compassionate grounds appointment requests.

It has come to the notice of this Ministry that cases of compassionate ground appointment are facing undue delay at the local Railway administration level. With a view to timely dispose compassionate ground appointment requests, it is advised to notify a fixed date (such as 10<sup>th</sup> of every month or next working day) for holding examination/suitability test of candidates to be followed by all Zonal Railways/PUs uniformly. This will help in avoiding delays in disposing compassionate ground appointment cases.
