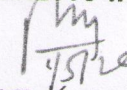
Railway Board vide letter no. 2018/Trans. Cell/Health/Medical Cards dtd. 04.01.2019 has communicated the approval for issuing the Uniform Medical Identity Cards pan India basis with regards to the colour scheme for serving and retired railway employees and their dependents.

Accordingly, South Central Railway has developed UMID software for generation of Smart Medical Cards for all the units in Indian Railways. In this module, the employee, Pensioner and all eligible dependents can be issued with split Medical Cards.

Application for issue of cards can be submitted online only on this module by the serving employees and pensioners (RELHS card holders). After necessary verification and approval by the administrators, the smart card will be generated online for print/ view /using in Hospitals. All eligible employees can register and apply online for issue of Medical Cards in the UMID portal at: digitalir.in/umid.

The detailed guidelines in the form of **User Manuals, Registration & Log-in Modalities, Brochures, Check-lists, application formats, Help-desk Modalities, FAQs** including educative Videos in multiple languages can be seen in the Home page of UMID portal.

It is therefore, requested to advise the staff under your control and give wide publicity among all the eligible Railway employees to register themselves **before 24.05.2019 without fail**.

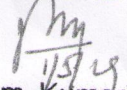

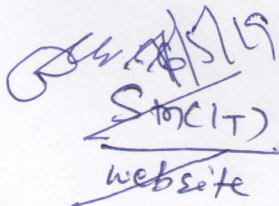
