Clarifications have been sought regarding revised designation of categories in Level-1 of Personnel Department in terms of Board's letter No. PC-VI/2009/I/1/3(Vol.II) dated 27.12.2012 (RBE 201/2018)

2. Attention is drawn towards Paragraph 4 of RBE No. 201/2018 where in Railways were advised that they may use the nearest appropriate revised designation to include the left-over category/categories, if any, under intimation to Board's Office.

3. Keeping in view above position and to maintain a uniformity across different Railways, the matter has been considered in Board's Office and it has been decided that the revised designation of **Office Asstt./Personnel** may be used for the categories in Level-1 (erstwhile Group 'D') of **Personnel Department** in all Indian Railways/PUs etc.
