**Sub: Date of superannuation of doctors in case they opt to superannuate on attaining the age of 62 years - clarification.**

Pursuant to issue of Board's instructions of even number dated 20.09.2018(RBE No. 1144/2018 , Dr. S.K. Patodi, former ACMS (H&FW)/Ratlam/WR and Dr. B. Sonowal, former PCMD/NFR, retired from railway service on 07.01.2019 and 10.01.2019 respectively, on attaining the age of 62 years. In their representations, they have submitted that their retirement be made effective from 31.01.2019 i.e. the last day of the month in which they had attained the age of 62 years.

2. The matter has been considered by the Board and have decided that Dr. S.K. Patodi & Dr. B.Sonowal would be treated as retired on 31.01.2019 after regularising the period of their respective absence i.e. w.e.f. 08.01.19 to 31.01.19 in case of Dr. S.K. Patodi and w.e.f. 11.01.2019 to 31.01.2019 in case of Dr. B. Sonowal, as leave, due and admissible to them at the time of their retirement. Dr. Patodi & Dr. Sonowal will be paid leave salary for the period of their leave subject to adjustment of the pension already paid to them for the said period and their retirement documents and PPOs will be re-prepared by their respective Railway Administrations as if they had retired on 31.01.2019.

3. All the Zonal Railways are directed to dispose of any such similar cases pertaining to their Railways in line with the above procedure under intimation to the Board's office.

4. This issues with the concurrence of the Finance Dte. of Railway Board.
