2. He has accepted the offer of appointment issued to him vide PCPO/BBS' Lr. No.ECoR/Pers/Rectt./S&G Quota (2018-19)/Jr.Clerk-cum-Typist/Appt/SS dtd.17.05.2019 with all terms and conditions mentioned therein for appointment as Junior Clerk-cum-Typist in Level-2.
3. He has to pass the requisite type writing test within a period of two years from the date of joining and failing to pass the type writing test within two years from the date of appointment, his appointment will continue to be treated as provisional till such time he passes the type writing test and no promotion/increment will be granted.
4. The seniority of the Sri Souvik Samaddar will be maintained in the combined ministerial cadre of GA/Pers/Med.Deptt. of ECoR/BBS & WPO/MCS after passing typewriting proficiency test.
5. He will be governed by New Pension Scheme as per RBE No.225/03.
