  - The above candidates are not eligible to undergo apprenticeship training if / (a) he /she has already undergone apprenticeship training under the Apprentices Act or (b) he/ she had training / work experience for an year or more or (c) presently undergoing/ Apprenticeship Training elsewhere.
  - The above trainees shall be terminated automatically after completion of training period of one year.
  - The above candidates are advised to report Chief Instructor/BTC or OS/Time Office on 29.03.2019 at 06.30 hrs. positively for their training.
