Para 215 of Indian Railway Establishment Manual (IREM) Vol.I. 1989 (Reprint Edition – 2009) inter-alia provides for viva-voce in the Selection process for the post of Instructors in recognized Training Institutes.

Vide Board's letter of even number dated 13.05.2019, uniform guidelines have been laid down for filling up the posts of Instructors in recognized Training Institutes. It has inter-alia been provided therein that the selection process shall consist of written test and class room trial. The provision of viva-voce has been done away with.

Para 215 of IREM Vol.I, which inter-alia provides for viva-voce in the selection process for the post of Instructors in recognized Training Institutes accordingly stands amended as per ACS No.265 enclosed herewith.
