
**Sub: Guidelines regarding written examination in compliance to RBE
No.97/2019 .**

Ref: Estt Srl No. 93/2019

Guidelines were issued vide Estt.Srl.No.93/2019 for conducting written examination in compliance to RBE No.196/2018 wherein the written examination was prescribed to be of 3 (Three) hours duration.

Now, in terms of Estt Srl No.138/2019 (RBE No.97/2019), it has been deided by the competent authority that the duration of OMR based written Examination will be 120 minutes.

This will take immediate effect. The written examination for which Notifications have already been issued and written examination is yet to be conducted, will also be of 120 minutes (Two hours) duration with modification to said notice. Other guidelines issued vide Estt Srl. No. 93/2019 will remain unchanged.
