- 1.0 In terms of Board's letter referred at (i) above, Central Railway have forwarded proposal with due approval of the General Manager to include the section Chalisgaon – Dhule (CSN-DHI), Jalamb-Khamgaon (JM-KMN) and Daund-Baramati (DD-BRMT) in the CC+8 routes.
