Sub: Running of freight trains on CC+8 routes.

(ii) Rates Master Circular/PCC/2015/0 dated 19.10.2015 and Corrigenda thereto circulated vide CCM/ECOR's Commercial Circular No.138(G)/2015 dated 20.10.2015 and Corrigenda thereto

- 1.0 In terms of Board's letter referred at (i) above, Eastern Railway have forwarded proposal with due approval of the General Manager to include the section Naihati Link Cabin - Halisahar (NHLC-HLR) by pass line in the CC+8 routes.
