Sub: Running of freight trains on CC+8 routes.

1.0 In terms of Board's letter referred at (i) above, Eastern Railway have forwarded proposal with due approval of the General Manager to include the section Poradanga– Manigram (PRDG-MGLE) , both Up & Dn lines in the CC+8 routes.
