

Subject: Revised Model Calendar for DPCs – regarding.

In terms of DoP&T's OM No. 22011/4/2013-Estt (D) dated 08.05.17, Railway Board has decided that: -

- (i) Wherever financial year based vacancy/panel year is being followed for empanelment/promotions/appointments to various grades including the post of General Managers/Equivalent, the same may be shifted to 'calendar year' from 2019 onwards.
  - (ii) The crucial date of eligibility will be 1<sup>st</sup> January of the vacancy/panel year w.e.f. 2020.
  - (iii) The APARs preceding T-2<sup>nd</sup> year may be taken as reckoning APAR. For example, if APARs for five years are to be taken for the vacancy year (1<sup>st</sup> January, 2020 to 31<sup>st</sup> December, 2020) the reckoning APARs shall be 2017-18, 2016-17, 2015-16, 2014-15 & 2013-14).
  - (iv) The year of 2019 being the transitional year, the vacancy period shall be from 1<sup>st</sup> April 2019 to 31<sup>st</sup> December 2019 for all empanelment/promotions/appointments to various grades wherever financial year based vacancy year is being followed. The reckoning APARs for this vacancy year shall be (2016-17, 2015-16, 2014-15, 2013-14 & 2012-13). The crucial date of eligibility shall be 1<sup>st</sup> April 2019 for the transitional year.
  - (v) Similarly, for GMs/equivalent, the empanelment for the year 2019-20 already approved by ACC will cease to exist on 31.12.19, 2019 being the transitional year. For anticipated vacancies during the panel year 2020 (1<sup>st</sup> January 2020 to 31<sup>st</sup> December 2020), a fresh panel shall be framed following the calendar year based panel year.
2. All are requested to take necessary action, accordingly.
