The Department of Pension & Pensioners' Welfare, vide their OM cited under Ref.(ii) above, have circulated a revised format for issue of Pensioners' Identity Card deleting the requirement for indicating Aadhaar No. in the earlier format.

2. Accordingly, the earlier format circulated vide Board's letter under Ref.(i) has been revised and enclosed as Annexure I & II. Henceforth Pensioners' Identity Cards may be issued to the Railway servants retiring under Railway Services (Pension) Rules, 1993 as per format at Annexure-I and to the Railway servants retiring under 'National Pension System' (NPS) as per format at Annexure-II.

3. Other conditions stipulated in Board's letter cited under Ref.(i) shall continue.
