
Sub: Out-of-Turn Promotions(OTP) to outstanding Sportspersons and Coaches to Officer Grade on sports accounts.

Attention is invited to Railway Board's letter of even number dated 17.08.2018 laying down the policy of Out-of-Turn Promotions for outstanding sportspersons and coaches to Officer Grade.

2. References are being received from various Railways seeking various clarifications. The same have been examined and decided as under:-

S.L.	Query	S.L.	Clarification
1	Whether the Board's policy letter dated 17.8.2018 has been issued with the concurrence of Finance Directorate/Railway Board.	1	The policy has been issued in consultation with Finance Directorate of Railway Board.
2	Whether a Special Supernumerary Group 'B' post may be created under GM's power with matching surrender for accommodating the said sportsperson.	2	Any existing vacant Group 'B' post of concerned Zonal Railway may be utilized for promoting sportsperson as OSD (Sports) under this policy.
3	Whether the Achievements for which OTP/Increments in Group 'C' have already been given may be considered for Officer Grade promotion also.	3	The achievements (for which OTP/increments in Group 'C'/non-gazetted category have already been given) can also be considered for grant of promotion to sportspersons in Officer Grade subject to fulfillment of the conditions mentioned in Board's letter dated 17.8.2018.
