

Sub: Appointment against sports quota- Revision of minimum educational qualification for direct recruitment to the post of Skilled Artisan.

Ref.: Board's letters No. E(NG)II/99/RR-I/66 dated 28.01.2000.

Attention is invited to Board's letter No. E(NG)II/99/RR-I/66 dated 28.01.2000 laying down the minimum educational qualification for direct recruitment to the post of Skilled Artisan in Grade Pay Rs. 1900/- (6th CPC) as "Course completed Act Apprenticeship/ ITI pass in relevant Trade."

The matter has been reviewed by the Board and it has been decided that henceforth for appointment against sports quota in Technician-III, the minimum education qualification should be prescribed as 10th pass. However, the training period for such Sports quota appointees will be 3 (three) years, unless they passes ITI qualification in the relevant Trade, in which case it will be 6 months.




