NB: The provisional panel of Shri Pradeep Kumar Jha for his promotion to Group-B/Ex-Cadre/ Tenure post of Protocol Officer in East Coast Railway has been approved by the General Manager/E.Co. Railway on 30.09.2019 and is in terms of PCPO/ECOR's Memorandum No.ECOR/Pers/Gaz/Sel/Gr.B/Protocol Officer dated 15.10.2019. His promotion is purely on ad-hoc basis for a period of 03 (three) years depending upon extension of currency of the post as well as his performance and is subject to (i) he will not have any prescriptive right over the post and future promotion, (ii) he is liable to be reverted to his substantive post at any time without assigning any reason whatsoever, (iii) he will seek promotion in his own parent cadre only and (iv) he is not undergoing any punishment under the RS D&A Rules, 1968.
