

Consequent on promotion of Shri L.V.Rao, SS/IRSE, SEN(CSP)/WAT to adhoc JAG and his transfer thereof to Construction organization vide item (4), the works of Concrete Sleeper Plants at RGDA, PDT and GRVD on WAT Division are assigned to Sr.DEN(Siding)/WAT, in addition to his own, until further orders.
11. The JAG post of Sr.DEN(West)/SBP (Post Code 03CO5P028), on vacation by item (6) above is transferred to KUR Division for operation as Sr.DEN(East)/KUR with incumbent Shri Rajesh Kumar Dash, adhoc JAG/IRSE and the JAG post of Sr.DEN(Central)/SBP(Post Code 03CO5P017) operated as Sr. DEN/East/KUR , is restored to SBP Division
12. 
