Sub: Running of freight trains on CC+8 routes.

Ref: (i) Board's letter No.2018/E&R/1(8)/4 dated 24.04.2018, circulated to Divisions vide this office letter No.CCM/356/Policy/PCC/Pt.VII/628 dt.24.05.2018.

(ii) Rates Master Circular/PCC/2019/0 dated 16.05.2019 and Corrigenda thereto circulated vide CCM/ECOR's Commercial Circular No.85(G)/2019 dated 17.05.2019 and Corrigenda thereto.

- 1.0 In terms of Board's letter referred at (i) above, South Central Railway has forwarded proposal with due approval of the General Manager to include the section namely Venkatachalam Road Junction – Obulavaripalli in the CC+8 route.
