Sub: Transportation of Dogs in First AC and First Class Compartments –
regarding

In partial modification of Rule No. 403(1) of IRCA Coaching Tariff Part-1 (Vol.III), it has been decided that maximum one dog per passenger on the same Passenger Name Record (PNR) shall be carried in AC First Class and First Class Compartments only, subject to the condition that the whole compartment/coupe (2 berths or 4 berths) is booked by the passenger or the group of passengers for his/her/their exclusive use. Other provisions of this Rule No. 403(1) shall remain unchanged.

2. These instructions will be effective with immediate effect.
3. This issues with the concurrence of Finance Directorate of the Ministry of Railways.
4. Necessary instructions may be issued to all concerned immediately.
