- 3) Shri Subash Chandra Sahoo, CYM/Puri in Group 'C', having been empanelled for promotion to the post of AOM in Group-B Service in East Coast Railway vide PCPO/ECOR's Memorandum No.ECOR/Pers/Gaz/Optg/AOM-70%/Select Panel/2017-19 dated 31.12.2019, is promoted and posted as AOM(G)/KUR (Postcode-11CO7P003) operated as AOM/Coaching/KUR and vacated by Shri Prashant Kumar, JS/IRTS on his promotion to Sr.Scale as DOM/Coaching/KUR.
- 4) The revenue Jr.Scale post of AOM/Coaching/KUR (Postcode-11CO8P004), which was operated as ACM/Coaching/KUR and presently lying vacant, is transferred to WAT Division and operated as AARM/BCHL, till further orders.
- 5) Shri L.D. - 7) Ms. Ameesha, JS/IRTS presently working as AOM(G)/WAT is posted as AARM/VSPS (Postcode-11CO7P014) against the post mentioned at (6) above.

NB: The provisional panel of Group 'C' staff at (1), (2), (3) and (5) for their appointment/promotion to the post of AOM in Group-B Service has been approved by the General Manager/E.Co. Railway on 31.12.2019 and is in terms of PCPO/ECOR's Memorandum No.ECOR/Pers/Gaz/Optg/AOM-70%/Select Panel/2017-19 dated 31.12.2019. Their promotion is subject to their not undergoing any punishment under the RS D&A Rules, 1968. They may exercise option for fixation of pay in Group 'B'/Operating service as AOM within one month from the date of their promotion in terms of CPO's Estt.Serial No.231/81 and as per extant rules.


