It has been decided to conduct Typewriting Test on 30.01.2020 at 10.30 hrs in the office of PCPO/ECoR/BBS, for the staff working as Jr. Clerks who are provisionally promoted from Group-D to Group-C/recruited against Scouts & Guides, Cultural, CG, Sports quota and Sr.Clerk against LDCE quota etc. in ECoR/HQ/BBS and required to pass the typewriting proficiency test for their confirmation/regularization in the grade.

The typewriting test shall be conducted as per the procedure laid down vide RBE No. 19/2011. The list of candidates required to appear the test is enclosed as Annexure-A.

The staff concerned may be advised to be in readiness to appear the said test. The staff concerned may be released with proper identification memo to report at PCPO office on 30.01.2020 at 10.00hrs without fail.

Jr.Clerk/Sr.Clerk recruited/promoted through the modes mentioned above who did not qualify in the mandatory typewriting test, should submit representation within 10 days of publication of this notice, if his/her name does not figure in the list enclosed.

All concerned are requested to give wide publicity of the typing test eligibility list among the staffs well in advance. If any of the candidates is on leave, sick, training or duty outside his/her headquarters, he/she may be informed well in advance regarding the time, date and venue of Typing test. Any staff unwilling to appear the Typing test may intimate to this office immediately along with unwillingness application.
