

**Sub: Assessment of vacancies in connection with selection to the post of Jr.Clerk-cum
-Typist against 33.33% DPQ and 16.67% LDCE Quota.**

Guidelines were issued vide Estt Srl.No EPS-7/2005 which inter-alia state calculation of vacancies without taking into account the anticipated vacancies for the purpose of conducting selection to the post of Jr.Clerk-cum-Typist against 33.33% DPQ and 16.67% LDCE Quota whereas Para-215(f)(i) of IREM-I provides for inclusion of the vacancies anticipated during next 15(Fifteen) months.

The matter has been reviewed by the competent authority and it has been decided that like other selections, vacancies anticipated during the next 15(Fifteen) months shall also be taken into account while calculating the vacancies for processing the selections for promotion to the post of Jr.Clerk-cum-Typist against 33.33% DPQ and 16.67% LDCE in terms of the provisions of Para Para-215(f)(i) of IREM-I.

This instruction will take effect from the date of issue of this letter.
