With the approval of the General Manager/East Coast Railway, following orders are issued.

1. The permanent vacant post of Sr. LO/HQ/BBS (Pc-12CO6P002) is temporarily downgraded to Jr. Scale till further order.
2. Shri P. Krishna Kumar, Retd. Sr. LO/WAT is re-engaged as Consultant (Law) at HQ/BBS temporarily against the post at (1) above.

(Authority: Railway Board's letter Nos. 2018/Trans Cell/S&T Contractual staff dtd. 25.10.2018 & dated 20.12.2018)

The above re-engagement is subject to the following terms and conditions:

- i. This scheme is experimental in nature and valid for 2 years from the date of issue of Railway Board's letter dt 25.10.2018 in reference. The period of engagement shall be initially up to 24.10.2020 and may be extended further as per Railway Board's instruction and requirement.
- ii. The engagement of Consultant shall not be considered as a case of re-employment.
- iii. Maximum age limit of the re-engagement shall be 65 years.
- iv. Monthly remuneration of a retired officer being re-engaged will be determined in terms of Railway Board's letter No. E(NG)II/2007/RC-4/CORE/1 dated 24.10.2019.
- v. Re-engaged officer shall not be entitled for requisites such as HRA,CCA, Transport Allowance, Residential accommodation, etc. However, when required to travel in connection with official works, TA/DA admissible to regular employee working in the same Grade will be admissible.
- vi. 12 days leave in a calendar year on pro-rata basis is admissible.
- vii. The designation shall be Consultant followed by trade name.
- viii. Re-engaged officer shall be discharged immediately on joining of selected candidate(s) from UPSC or departmental selection or as per the recommendation of PHOD/CHOD concerned.
- ix. The Re-engaged officer shall work under the guidance and command of assigned Controlling Officer.
- x. The consultant shall not divulge any information gathered by him/her during the period of assignment related to the organisation to anyone who is not authorised to know/have the same.
- xi. Re-engaged officer shall not be given the financial and D&AR powers and shall not be authorised to issue any safety certificate.
- xii. Monthly remuneration of a retired Senior Scale officers being re-engaged against the Junior Scale post will be determined by reducing Pension from his/her last pay drawn(i.e. Basic Pay+DA) by the officer in Junior Scale /Group B just before the promotion to Senior Scale minus the pension of the retired officer. In case the last working of the retired Senior Scale Officers, re-engaged, in Junior Scale/Group B post, was during VI CPC, then the corresponding amount will be worked out by applying 2.57 fitment factor and notional placement in the corresponding pay scale to ascertain corresponding VII CPC pay.
