However, based on his application dated 11.3.2014, he was directed to report CMS/KUR for re-medical examination vide SPO(Con)/Co-Ordn/ECoR/BBS's letter dated 15.4.2014 and he has been declared "fit for Group-B/AEN non-field post only such as ADEN (Planning), ADEN (Design), ADEN (TP), ADEN (Land), ADEN (General)" by CMS/KUR vide his certificate dated 04.06.2014
