With the approval of the General Manager/East Coast Railway, the following orders are issued.

- 1) Shri.N.R. Mohanty, Ch.PI/BBS in Group-C, having been empanelled provisionally for promotion to the post of PRO in Group-B/PR service vide PCPO/ECOR/BBS Memorandum No.ECOR/Pers/Gaz/GA/PR/PRO/Select Panel/2019-21 dated 20.01.2020, is promoted and posted as PRO/KUR at BBS (Postcode-05CO8P009) against the existing vacancy.
- 2) Shri Vikas Kumar, Ch.PI/BBS in Group-C, having been empanelled provisionally for promotion to the post of PRO in Group-B/PR service vide PCPO/ECOR/BBS Memorandum No.ECOR/Pers/Gaz/GA/PR/PRO/Select Panel/2019-21 dated 20.01.2020, is promoted and posted as PRO/HQ/BBS (Postcode-10CO8P011) against the existing vacancy.
- 3) Shri Tribikram Seth, Ch.PI/BBS in Group-C, having been empanelled provisionally for ad-hoc promotion to the post of PRO in Group-B/PR service vide PCPO/ECOR/BBS Memorandum No.ECOR/Pers/Gaz/GA/PR/PRO/Select Panel/2019-21 dated 20.01.2020 for a period for six months under the principle of 'best among failed SC/ST candidates', is promoted to Gr.B/PRO on ad-hoc basis and posted as PRO/SBP (Postcode-6976) against the existing vacancy.

NB: (i) The provisional panel of PROs at (1) & (2) above for their appointment/ promotion to the post of PRO in Group-B/PR service has been approved by the General Manager/E.Co.Railway on 17.01.2020 and is in terms of PCPO/ECOR Memorandum No.ECOR/Pers/Gaz/GA/PR/PRO/Select Panel/2019-21 dated 20.01.2020. Their promotion is subject to their not undergoing any punishment under the RS D&A Rules, 1968. They may exercise option for fixation of pay as PRO/Gr.B within one month from the date of their promotion in terms of CPO's Estt.Serial No.231/81 and as per extant rules.

(ii) The provisional panel of of Shri Tribikram Seth at S.No.(3) above to the post of PRO in Group-B/PR service on ad-hoc basis for a period of six months has been approved by the General Manager/East Coast Railway on 17.01.2020. (ii) Inclusion of his name in the panel will depend upon his performances during the six months period after the date of his ad-hoc promotion in terms of Railway Board's letter No.88-E(SCT)/23/1 dated 28.06.1995. The ad-hoc promotion as and when given shall not confer any right upon him to claim automatic empanelment to PRO in Group 'B'/PR service. (iii) He should be given all facilities to improve his knowledge and come upto the requisite standard, if necessary, by organizing special coaching classes during the six months period of his ad-hoc promotion. (iv) On completion of his six months' ad-hoc promotion, the department concerned will put up the case to the General Manager through Dy.CPO(Gaz) on the basis of special working report of the candidate for a review and continuance of the said candidate in the higher grade will depend upon this review. (v) The staff concerned, if failed to come up to the requisite standard after taking all steps as above, will not be included in the panel and the vacancy will be treated as shortfall. (vi) On being finally empanelled, his position in the panel will be assigned at the appropriate place. (vii) His promotion to Group-'B'/PR service as PRO is subject to his not undergoing any penalty under the RS D&A Rules, 1968 and is in terms of PCPO/ECOR/BBS' Memorandum No.ECOR/Pers/Gaz/GA/PR/PRO/Select Panel/2019-21 dated 20.01.2020. (viii) He may exercise option for fixation of his pay as PRO/Gr.B within one month from the date of his ah-hoc promotion as per extant rules.
