General Terms and Conditions:

1. Applicants are requested to submit their applications along with their photographs and EMD for Rs. 2,000/- (through DD drawn in favor of FA & CAO, E.Co.Railway, Bhubaneswar, payable at VISAKHAPATNAM), in Sr. Divisional Commercial Manager's Office, DRM office Building, Dondaparathi Junction, Visakhapatnam – 530004. The applications will be available in the office on free of cost or can be downloaded through website <http://eastcoastrail.indianrailways.gov.in>
2. The applicant should not be under 18 years of age and should have passed at least class-X exam. (Proof of educational qualification and Date of Birth should to be submitted).
3. The applicant should be a resident of the local block/ Tehsil/ Mandal in which the 'E' Category Station is located where STBA is proposed to be engaged (Proof of residence to be enclosed obtaining from Competent Authority) and also submit a copy of photo identity card issued by Govt. i.e. voter identity card/ Aadhar card/Driving License/ Pan card.
4. The selected applicant will also have to produce a certificate from the Police Station serving his/ her locality that he/she has no criminal record and no criminal case is pending against him/ her.
5. A Refundable security deposit of Rs. 5,000/-(Rs. Five thousand only) and Bank Guarantee/Fixed Deposit of Rs. 20,000/-(Rs. Twenty thousand only) shall be deposited by the selected applicant (STBA), to Railway. On completion/ termination of contract pending dues will be adjusted from the security deposit and balance refunded to STBA.
6. While furnishing application, applicant will give a declaration that he/she has not been appointed as STBA at any other station. Only one applicant can be engaged as STBA at only one station and he/she will be required to disburse unreserved tickets throughout the day i.e. twenty-four (24) hours - Declaration Form enclosed.
7. Selection of STBA will be done by the Tender committee. Out of the applicants fulfilling the conditions the candidate (s) who opts for the least commission (in 4 % commission slab) will be selected for Engagement as STBA. In case more than one applicant quotes the same commission rate, the selection will be based on the draw of lots. Applicant has to quote the percentage of commission from 0% to 4% in the 4% commission slab. No negative bids will be considered. Applicants can quote commission in fraction up to two decimal points only.

8. The commission shall be payable as follows:-

Slabs	Sales Turn over in Rs	Commission percentage payable on sales turnover.
Slab 1	1-15,000	15% (Minimum Rs.500/-)
Slab 2	15,001-50,000	12%
Slab 3	50,000-1,00,000	9%
Slab 4	> 1,00,000	4% or commission quoted by the applicant, whichever is lower.

Calculation of commission will be done on monthly basis. The commission shall be calculated on monthly sales turn over. The commission shall be paid on net sales and in case of concessional tickets it shall be on the actual fare collected by the Railways.

9. The cost of Hardware & Software (including maintenance), electricity and hiring of channel Will be borne by the Railways. The space will also be provided by the Railways on free of cost.
10. Period of engagement is for Three (3) years.



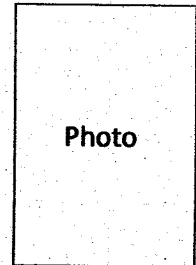
