
Attention is invited to Railway Board letter under reference (i), wherein at para 5.1 it was notified that Ores, Minerals, Coal and Coke will be the restricted Commodities for movement by containers.

Under reference (ii), approval of Railway Board was communicated for permitting movement of all types of Ores, Minerals, Coal and Coke in Import containers only, which are transported purely under Customs bond and seal, in partial relaxation to the stipulation at para 5.1 of letter under reference (i).

Under reference (iii), approval of Railway Board was communicated for permitting movement of import containerized traffic of restricted commodities (Ores, Minerals, Coal and Coke) at FAK rates , in seal cut containers , subject to the following conditions:

- I) The imported containerized cargo is moved in the same containers, after custom clearance, in which they have arrived customs bonded.
 - II) The SMTP detail can be relied upon by the Goods clerk to verify the same. This permission was valid till 04.09.2019. The permission has now been extended w.e.f 05.09.2019 till further advice.
- Divisions shall continue to maintain the record of movement of such restricted commodities in import containers for perusal and review by Railway Board
This issues with the consent of Traffic Commercial and concurrence of Finance Directorate of Railway Board. All concerned to note and act accordingly.


