Sub : Clarification on Definition of "Terminal" with respect to "Transportation Products"

Railway Board has reviewed the definition of "Terminal" laid down in above referred circulars with respect to "Transportation Products", and following is clarified:

- 1) Definition of "Terminal" was inadvertently included in some of the above referred circulars for "Transportation products" as well; and therefore does not hold good. It may though be noted that conditions for each transportation product were defined separately in policy circulars.
- 2) It is clarified that O-D pairs or Terminal combinations as laid-down in annexure to above-referred circulars are sacrosanct, including Railway goods sheds, PFTs, private sidings and ports etc
- 3) However, in certain cases, it was left to Zonal Railways to decide the O-D pairs or Terminal combination; for eg. Western Railway in Annexure II to ref (vi) dated 05.06.2015. It is clarified that in such cases, Zonal Railway was empowered to identify the O-D pair or terminal combinations, subject to the laid down conditions in the concerned annexure, irrespective of these terminals being Railway Goods shed, PFTs, Private sidings or Ports.
- 4) Definition of "Terminal" as applicable for Freight Incentive Schemes shall continue to apply, as per the tenure of respective policies and as per all letters and instructions in this regard.
