Sub: Restriction of loading & unloading at NDLS, DLI & ANVT station for Deepawali & Chhath Pooja rush arrangements.

Ref: Dy.CCM(FM-II)/Northern Railway's Ir. No. 1329-R/Opening & Closing/2019 N.R.B.H.NDLS, dt 21.10.2019 (Northern Railway Rates Opening/Closing circular No. 08 of 2019(Case no. 1329-R/O&C/2019 dt 21.10.2019).

An extract of DY CCM(FM-II)/ Northern Railway's letter under reference is reproduced below for information & necessary action:-

"Restriction has been imposed by Delhi division on all types of parcel handling (including handling of leased SLRs, AGCs, VPs & demand VP), loading and unloading strictly prohibited from **25.10.2019 to 01.11.2019** in Delhi area (i.e NDLS, DLI & ANVT stations) of Delhi division. These restrictions are also applicable for passing trains originating from other zones/divisions and having stoppage in Delhi area for loading & unloading. However, personal luggage may be allowed in the passenger coach only and booking of registered Newspaper/Magazines shall be permitted after observing all commercial formalities. Moreover, at ANVT there will be no restriction on handling of leased space from washing line & stabling line. These restrictions will be applicable only for leased space handled at platform. Booking of departmental parcels will be restricted from 23.10.2019 to 01.11.2019 at NDLS, DLI & ANVT stations.

The stacking of Parcels at platforms and cross movement of the trolleys from one end of the platform to another end is strictly prohibited from **25.10.2019 to 01.11.2019 at NDLS, DLI & ANVT stations.**"

All concerned may be advised for strict compliance.


