## Commercial Circular No.218(G)/2019

**Sub: Running of freight trains on CC+8 routes.**

- 1.0 In terms of Board's letter referred at (i) above, West Central Railway has forwarded proposal with due approval of the General Manager to include Sargaon Banjari – Bir (SL) Section of West Central Railway in the CC+8 routes.

- 4.0 These instructions shall come into effect from **26.10.2019** and shall remain valid till further advice.


