Sub: Own Your Wagon Scheme (OYWS)-Extension of agreement after completion of 20 years lease period.

Several references have been received in Board's office regarding the course of action to be taken with respect to the wagons procured under Own Your Wagon Scheme (OYWS) after expiry of 20 years period.

2. The matter has been deliberated upon in Board's office. Competent Authority have now decided to follow the following procedure in regard to wagons procured under 'Category-A' and 'Category-B' i.e. General Service Wagons under OYWS :-

2.1 For wagons which have been found mechanically and operationally FIT for further service after expiry of 20 years (secondary lease) period, agreement should be extended for another 10 years or till the codal life of wagons whichever is earlier.


2.2 The above extension (tertiary lease) shall be done by the Zonal Railways. The lease charges payable should be decided by the Zonal Railways subject to lease charges being capped at maximum 0.5% per annum.


2.3 At the end of this tertiary lease, Indian Railway will become owner of these wagons and no scrap value would be payable by Indian Railways to the investor.

3. The case of M/s Manikgarh Cement Ltd. over South Central Railway is being dealt separately.

4. These instructions shall be effective retrospectively, i.e. from the date of expiry of 20 years period with reference to the signing of the Own Your Wagon Scheme (OYWS) Agreement. Rest of the conditions of OYWS agreement shall remain unchanged.


5. In case of the wagons which are not traceable, the lease charges at the rate of upto 0.5% (maximum) may be paid for the codal life or 10 years whichever is earlier. As regarding condemned wagons, the action may be taken as per the relevant para of the policy circular.




