

- 1.0 In terms of Board's letter referred at (i) above, South Central Railway has forwarded proposal with due approval of the General Manager to include **Jankampet (JKM) – Bodhan (BDHN) (SL) BG** section of South Central Railway in the CC+8 routes.
- 2.0 Please refer to Annexure III to Rates Master Circular under reference at (ii) above, wherein list of CC+8 routes is prescribed. Now, sanction of the Competent Authority is hereby accorded to include **Jankampet – Bodhan (JKM - BDHN) (SL) BG** section of South Central Railway in the list of already identified CC+8 routes.
- 3.0 Corrigendum No.14 to Rates Master Circular/PCC/2019/0 dated 25.11.2019 {circulated vide this office Commercial Circular No.237(G)/2019 dt.26.11.2019} is hereby superceded.
- 4.0 All other details of the Rates Master Circular & Corrigenda thereto under reference shall continue to apply unchanged.
- 5.0 These instructions shall come into effect from **27.11.2019** and shall remain valid till further advice.
