**Sub: Running of freight trains on CC+8 routes.**



- 1.0 In terms of Board's letter referred at (i) above, South Western Railway has forwarded proposal with due approval of the General Manager to include **Chikbanavar (BAW) - Hassan (HAS) Single line section** of South Western Railway in the CC+8 routes.
- 2.0 Please refer to Annexure III to Rates Master Circular under reference at (ii) above, wherein list of CC+8 routes is prescribed. Now, sanction of the Competent Authority is hereby accorded to include **Chikbanavar - Hassan (BAW - HAS) Single line section** of South Western Railway in the list of already identified CC+8 routes.
- 3.0 All other details of the Rates Master Circular & Corrigenda thereto under reference shall continue to apply unchanged.
- 4.0 These instructions shall come into effect from **06.12.2019** and shall remain valid till further advice.


