
With the approval of the General Manager/East Coast Railway, the following orders are issued.

- 1) The JAG post of Sr.DEN(Siding)/KUR (Pc-03CO5P014) of Open Line, presently being operated as Dy.CE(Works)/ECoR/BBS, is temporarily transferred to Construction organization and operated as Dy.CE(Con)/Boudh under CPM/BBS till such time the post is restored. The works of Sr.DEN(Siding)/KUR are assigned to sectional Sr.DEN/DEN of KUR Division in their jurisdiction, in addition to their own.
- 2) The JAG post of Sr.DEN(Siding)/WAT (Pc-03CO5P043) of Open Line is temporarily transferred to Construction organization and operated as Dy.CE(Con)-II/VSKP under CPM-II/VSKP till such time the post is restored. The works of Sr.DEN(Siding)/WAT are assigned to sectional Sr.DEN/DEN of WAT Division in their jurisdiction, in addition to their own.
- 3) Shri M. Babu Rao, SG/IRSE, presently working as Sr.DEN(Siding)/WAT (Pc- 03CO5P043) is posted as Sr.DEN(Bridge)/WAT (Post Code 03CO5P026) vice Shri A. Gouri Shankar Rao, SG/IRSE. Shri M. Babu Rao will move first.
- 4) Shri A. Gouri Shankar Rao, SG/IRSE, working as Sr.DEN(Bridge)/WAT (Post Code 03CO5P026) is transferred to Construction Organization and posted as Dy.CE(Con)-II/VSKP (Post Code 03CO5P043) against the JAG post arranged at (2) above.
- 5) Shri Rabindra Kumar Mohanty, SS/IRSE, on return from deputation to Anugul Sukinda Railway Ltd.(ASRL), is appointed to officiate in JAG and posted as Dy.CE(Con)/Boudh (Pc-03CO5P014) under CPM/BBS against the JAG post arranged at (1) above.

- 6) Consequent on transfer of the JAG post of Sr.DEN(Sdg)/KUR (Pc- 03CO5P014) to Construction Organisation for operation as Dy.CE(Con)/Boudh vide (1) above, the vacant JAG post of Sr.DEN(Bridge)/KUR (Pc- 03CO5P018) is transferred to ECoR HQ and operated as Dy.CE(Works)/ECoR/BBS to accommodate Shri J.Atchi Babu, JAG/IRSE, till further orders.
- 7) Consequent on transfer of the vacant JAG post of Sr.DEN(Bridge)/KUR (Pc- 03CO5P018) to ECoR HQ for operation as Dy.CE(Works)/BBS vide (6) above, the temporary posting of Shri Sudarsan Naik, SS/Gr.B/Civil Engg as DEN(Bridge)/KUR (Pc-03CO6P002), ordered vide item-5 of PCPO/ECoR's O.O. No. 13/2020 dated 23.01.2020, is terminated and Shri Naik is now posted regularly as DEN(Bridge)/KUR, by operating the vacant Sr.Scale post of Sr.AEN/SBP (P- 03CO6P002), till further orders.
