


**Sub: On-line Pre-selection Training to SC/ST Candidates for Selections held for promotion to Group 'B' posts.**

Recently, a reference has been received from one of the Zonal Railways for imparting online Pre-Selection Training to reserved category candidates appearing in the Selections for promotion to Group 'B' posts in view of the Covid-19 pandemic where it is difficult to organize institutional training while maintaining social distancing and other covid-19 related measures. The matter has been examined in consultation with Training and Reservation directorates and herein it is advised that the issue may be decided after consulting the Zonal Executive Committee of All India SC & ST Railway Employees' Association (AISCSTREA).

2. Further, as has been mentioned in Board's aforementioned letter, the course content, design and module of the Pre-Selection Training may be decided by the PHOD of the concerned department.
