Sub: Restriction of Parcel traffic over Delhi area in connection with Republic Day.

Ref: Dy.CCM(FM-II)/Northern Railway's letter No. 36-RD/982/Restriction/Parcel/Pt-II dated 16.01.2020.

An extract of the Dy.CCM(FM-II)/Northern Railway's letter No. 36-RD/982/Restriction/Parcel/Pt-II dated 16.01.2020 is reproduced below for information & necessary action:-

"Keeping in view the security arrangement during Republic Day celebrations, restriction is hereby imposed on all types of Parcels transactions (including lease) in Delhi area (NDLS, DLI, HNKM, ANVT, DEE & ANDI) on 23, 24, 25 & 26 January-2020. Parcel godowns and platforms shall remain free of parcel packages/packings. In the wake of special arrangements this year, restriction is imposed on both inward & outward traffic including leased SLR, AGC & VPs at all the aforesaid stations.

The personal luggage may be allowed in the passenger coach only and booking of registered newspapers and magazines shall be permitted after observing all commercial formalities.

This restriction is applicable on all types of parcels transactions (including lease) SLR, AGC and VPs of the trains originating from Delhi area stations (i.e NDLS, DLI, HNKM, ANVT, DEE & ANDI) and also applicable for passing trains originating from other divisions/zones, having stoppages in Delhi area for loading/unloading".

All concerned to note and act accordingly.
