Sub: Delivery of Goods at destination in absence of RR.

Ref: Board's letters No.TC-I/2019/103/1 dated 24.03.2020, dated 27.03.2020 and dated 16.04.2020 circulated vide this office Commercial Circular Nos.66(G)/2020 dated 25.03.2020, 71(G)/2020 dated 27.03.2020 & 85(G)/2020 dated 17.04.2020 respectively.

Please refer to Board's letters under reference stipulating procedure for granting delivery of Goods (i) in case on non-receipt of RR & unavailability of indemnity bond and (ii) in case of self RR, during country wide lockdown. These guidelines are valid upto 03.05.2020.

The matter has been examined and the competent authority has decided to extend the currency of above- mentioned guidelines beyond 03.05.2020 till 17.05.2020.
